- 7. Sealed or electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12 pm on 2078/11/09. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2 PM on 2078/11/09 at the office of Bethanchowk Rural Municipality. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 30,00,000.00, which shall be valid for 30 days beyond the validity period of the bid 2079/04/04.
