- 1. Bethanchok Rural Municipality has allocated towards the cost of Construction/Upgrading of 1.Sallaphed Parthali Geldung Road 2.Bhanjyang Golgaun Bhugdeu Medhamsu Road 3.Tipchowk Parthali Road and intends to apply part of the funds to cover eligible payments under the Contract for Road Construction/Upgrading Contract No: BRM/081/82/WORKS/16. Bidding is open to all eligible as per Section V of bidding document.
- Bethanchok Rural Municipality invites electronic bids only from eligible bidders for the construction of Construction/ Upgrading of 1.Sallaphed Parthali Geldung Road 2.Bhanjyang Golgaun Bhugdeu Medhamsu Road 3.Tipchowk Parthali Road at Bethanchok Rural Muncipality under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 13,00,00,000.00
- Minimum Work experience of similar size and nature: At least One Road Construction Contracts within the last ten (10) years, each with a value of at least NRs 5,16,00,000.00 that have been successfully or are substantially completed and that are similar to the proposed works.
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. Bidder should submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document NRs 5,000.00 in the Project's Rajaswa (revenue) account as specified below.

- 6. Pre-bid meeting shall be held at *Bethanchok Rural Municipality, Kavrepalanchowk* at 2081/09/28 at 11:00 AM.
- Electronic bids must be submitted through PPMO's e-GP system <u>www.bolpatra.gov.np/egp</u> on or before 12 PM on 2081/10/13. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at *1:00 PM* on *2081/10/13* at the office of *Bethanchok Rural Municipality, Kavrepalanchowk*. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of *NRS 21,50,000.00* which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
